Children are enrolled for the full school year (or portion remaining) and the family is responsible for the full tuition balance from the date of acceptance. Tuition for the full period of enrollment is not subject to adjustment because of illness, absence, or withdrawal from school. The rates shown below reflect a minimum of 1% and 3% discounts taken from the Option C base rate. Tuition rates include, where applicable, snack fees, and student-owned books.

*\*Toddler-Kindergarten - A non-refundable registration of \$150 (new students) or \$75 (returning students and siblings) is required.*

### **TODDLER (18 months-3 years) HALF DAY 8:30-11:30 a.m. Monday through Friday**

---

HALF DAY TUITION PAYMENT OPTIONS: Montessori class only (= Approx. \$225 per week)

- Option A \$8611 One payment of \$8611, due May 10, 2022  
Option B \$8796 Four payments of \$2199, due May, August, November 2022 & February 2023  
Option C \$8910 Ten payments of \$891, due monthly May 2022 through February 2023

### **TODDLER (18 months-3 years) FULL DAY—Montessori class + full day care 7 a.m.-6 p.m. Monday through Friday**

FULL DAY TUITION PAYMENT OPTIONS: (= Approx. \$410 per week)

- Option A \$15,836 One payment of \$15,836, due May 10, 2022  
Option B \$16,150 Four payments of \$4037.50, due May, August, November 2022 & February 2023  
Option C \$16,326 Ten payments of \$1632.60, due monthly May 2022 through February 2023

### **PRESCHOOL/KINDERGARTEN (3-6 years) HALF DAY CLASSES 8:30-11:30 a.m. 12:30-3:30 p.m. Monday through Friday**

---

HALF DAY TUITION PAYMENT OPTIONS: Montessori class only (= Approx. \$200 per week)

- Option A \$7660 One payment of \$7660, due May 10, 2022  
Option B \$7820 Four payments of \$1955, due May, August, November 2022 & February 2023  
Option C \$7900 Ten payments of \$790, due monthly May 2022 through February 2023

### **PRESCHOOL/KINDERGARTEN (3-6 years) FULL DAY CARE Half-day Montessori class + unlimited day care 7 a.m.-6 p.m. Monday through Friday**

---

All full-day children will attend a Montessori half-day class in the morning. For the remainder of the day, they will be supervised by trained staff in modified Montessori rooms. Full day care tuition includes the Montessori class and unlimited day care hours. A separate room for sleeping is available for those children who nap.

FULL DAY CARE TUITION PAYMENT OPTIONS: (= Approx. \$360 per week)

- Option A \$13,864 One payment of \$13,864, due May 10, 2022  
Option B \$14,132 Four payments of \$3533, due May, August, November 2022 & February 2023

**FULL-DAY PRESCHOOL CLASS 8:30 a.m.-3:30 p.m.****Monday through Friday**

---

Full-day preschool is an academic program for children younger than kindergarten age in which they spend the full day in the Montessori classroom.

FULL-DAY PRESCHOOL TUITION PAYMENT OPTIONS: (= Approx. \$365 per week)

Option A \$14,003 One payment of \$14,003, due May 10, 2022

Option B \$14,317 Four payments of \$3579.25, due May, August, November 2022 & February 2023

Option C \$14,472 Ten payments of \$1447.20, due monthly May 2022 through February 2023

Extra hours are available to full-day preschool students from 7-8:30 a.m. and 3:30-6 p.m. Hours are billed as used.

**EXTENDED DAY KINDERGARTEN, ELEMENTARY & MIDDLE SCHOOL****8:30 a.m.-3:30 p.m.****Monday through Friday**

---

EXTENDED DAY KINDERGARTEN, ELEMENTARY & MIDDLE SCHOOL TUITION PAYMENT OPTIONS:  
(= Approx. \$365 per week)

A \$550 non-refundable registration fee is required with the application. \$500 of this amount will be applied to tuition.

Option A \$14,003 One payment of \$14,003, due May 10, 2022

Option B \$14,317 Four payments of \$3579.25, due May, August, November 2022 & February 2023

Option C \$14,472 Ten payments of \$1447.20, due monthly May 2022 through February 2023

**HOURLY or FLAT RATE EXTRA CARE**

---

DHMC provides quality before-and after-class care for enrolled children. (Unlimited extra care hours are included in the tuition for toddlers and preschoolers enrolled in full day care.)

HOURLY (for any enrolled child): \$8 per hour, prorated to the quarter hour. Each child's costs will be calculated and billed at regular intervals. This service may be used on a consistent or occasional basis.

FLAT RATE (for children enrolled in full-day preschool, Extended Day Kindergarten, Elementary or Middle School): \$2800 per school year, paid in full in September, or in nine monthly installments of \$342, due on the first day of the months September through May (total \$3078). These numbers represent 1.8 or 2 hours per day for the school year only (7-8:30 a.m. & 3:30-6 p.m.) Second or additional children from the same family will receive a 20% discount on flat rate extra care charges.

Extra care fees are paid directly to DHMC. Hourly extra care is billed as used. Flat rate children are entitled to unlimited use on days the school is open.

**FAMILY TUITION DISCOUNTS**

---

Second children from the same family receive a 10% discount on tuition. This applies only to two children enrolled in full-day programs at any combination of age levels. The discount will be taken from the lowest payment option selected. Please inquire about rates for larger families.

## **ADDITIONAL CHARGES**

---

**FACTS TUITION MANAGEMENT ADMINISTRATIVE FEE:** FACTS fees are \$45 per family for quarterly and monthly payments. This fee will be added to the yearly tuition obligation. Families choosing the single-payment option will not incur a FACTS tuition management fee, although they will have a FACTS account.

**LATE PAYMENTS:** A \$30 per month charge will be added to tuition that is unpaid ten days after the due date.

**NSF CHECKS:** A fee of \$30 will be charged for each check that is returned by the bank as NSF or otherwise not collectible.

**LATE PICKUP:** A \$2 per minute late fee applies after 6 p.m. These charges are included on hourly day care bills and paid to the school, but go in their entirety to the caregivers who stay late.

## **UNFORSEEABLE EVENTS**

---

The school shall not be liable for any failure or delay in the performance of its duties or obligations to the extent such failure or delay is caused by a force majeure or an event beyond the school's reasonable control. This includes but is not limited to a fire, flood, act of God, war, government action, act of terrorism, epidemic, pandemic, natural disaster or other major upheaval which renders performance impractical, illegal, impossible or otherwise inadvisable. In such an event, the school's duties and obligations shall be suspended until such time as the school, in its sole discretion, determines that it may safely and ably resume performance.

The school shall provide notification of such a suspension by a reasonable time and method. During such a suspension parents shall make all payments due to the school and there will be no refund of tuition, fees, or other payments previously made. As an alternative to suspending performance, the school may elect to operate on a distance-learning basis, may choose to extend or shorten its school year, and may adopt an alternative schedule to complete its school year curriculum.
